LICENSE AGREEMENT - This "Agriculture Student Housing License Agreement" is entered into between the Trustees of the California State University by Cal Poly State University, hereinafter called "University," and the above named applicant, hereinafter called "Licensee." This license is for the summer, fall, winter, and spring academic year quarters.

FEES - Licensee is hereby obligated to pay fees in advance of the fee period as outlined in the "Agriculture Housing Fee Schedule" below. The License and Fee Period for the 2011/2012 Academic Year is June 13, 2011, through June 10, 2012, unless sooner terminated under the provisions of this License. Each installment payment covers housing fees for Summer, Fall, Winter, and Spring Quarters, respectively at the daily rate of \$10.40. A nonrefundable service charge of \$5.00 per installment payment is required. There is a \$25.00 late fee for each late installment payment.

OCCUPANCY - University hereby grants to Licensee permission to occupy a bed space within the Agriculture Housing facility as a Licensee for the fee period occupancy dates as listed below, unless sooner terminated under the provisions of the "Agriculture Student Housing License Agreement." Specific assignment of a space shall be made by the University and may be changed due to administrative necessity.

By signing this License Signature Page, Licensee acknowledges that he/she has read and understands the Agriculture Student Housing License Agreement - 2011/2012, and agrees to the License, including this License Signature Page, the License Terms and Conditions, the Agriculture Housing Fee Schedule, and all referenced documents, has received a copy of the Agriculture Housing Handbook, and that this License financially and legally obligates the Licensee to a bed space in an Agriculture Housing unit for the 2011/2012 Academic Year.
