**LICENSE AGREEMENT** - This Agriculture Student Housing License Agreement is entered into between the Trustees of the California State University, San Luis Obispo, hereinafter called "University," and the person named below hereinafter called "Licensee."

**FEES** - Licensee is hereby obligated to pay fees in advance of the fee period as outlined in the "Agriculture Housing Fee/Payment Schedule" below. Each installment payment covers housing fees for the Summer, Fall, Winter, and Spring Quarters, respectively at the daily rate of \$9.52. A nonrefundable service charge of \$5.00 per installment payment is required. There is a \$25.00 late fee for each late installment payment except for the first installment.

**OCCUPANCY** - SEE FEE/PAYMENT SCHEDULE BELOW FOR EXACT OCCUPANCY DATES. The University hereby grants to the Licensee permission to occupy a bed space within the Agriculture Housing facility as a Licensee for the fee period listed below, unless sooner terminated under the provisions of this License Agreement. Specific assignment of a space shall be made by the University, and may be changed from time to time. In consideration for the right to occupy an assigned bed space within the housing facility at University, Licensee hereby agrees to make payments to University per the "Agriculture Housing Fee/Payment Schedule."

I (we) have read the entire "AGRICULTURE HOUSING LICENSE AGREEMENT" and "TERMS AND CONDITIONS," and have received a copy of the "AGRICULTURE HOUSING HANDBOOK", and I (we) agree to the terms. I (we) understand that signing this "AGRICULTURE HOUSING LICENSE AGREEMENT" financially and legally obligates the Licensee to reside in Agriculture Housing facilities.
