The award, established in 1998 by CSU Trustee Stanley T. Wang and his family, recognizes one CSU administrator and four faculty members each year for their exemplary achievements and contributions to the CSU. The recognition includes a one-time award of \$20,000. As part of the award nomination process. Cal Poly to Provide Free Tax Preparation for Underserved Communities

The Orfalea College of Business is once again providing free tax return preparation assistance through the Volunteer Income Tax Assistance program (www.cob.calpoly.edu/vita). The oncampus VITA clinics will be held from 10 a.m. to 2 p.m. Saturdays from Jan. 29 through March 12. This year, all community members are required to schedule an appointment at www.myfreetaxes.org. More than 50 accounting students will prepare tax returns for local individuals and families earning less than \$58,000. These IRScertified students will prepare returns while Orfalea College of Business faculty and volunteer certified public accountants review and file the returns. The college has hosted VITA clinics on campus since 1992. In the last decade, students have helped prepare more than 7,000 tax returns for community members. The clinics serve as a valuable, hands-on senior project, allowing students to prepare returns, interact with clients and help underserved communities.

Safer to Host Speaker on Cyberstalking

In recognition of Stalking Action Month, Safer is hosting "Stalking in the Digital Age," a keynote address by Adam Dodge of EndTAB (End Technology-Enabled Abuse) from 11 a.m. to noon Thursday, Jan. 27. A licensed attorney, Dodge is dedicated to addressing the existing and future threats posed by technology to victims of crime and gender-based violence. He has written and presented extensively on cyberstalking, technology-enabled abuse and non-consensual pornography, and he co-authored a domestic violence advisory on the emerging threat of "deepfakes." Dodge founded EndTAB in 2019 and delivers innovative technology-enabled abuse trainings and presentations to organizations, nonprofits and governments around the world. Virtual Presentation, Q&A with Civil Rights Attorney Set for Feb. 14

Faculty and staff are invited to a virtual presentation, "ADA Law Protects Us All," with Paul Grossman from 3-5 p.m. Thursday, Feb. 14. The talk will focus on student academic accommodations. Grossman, J.D., served for more than 30 years as chief civil rights attorney for the U.S. Department of Education Office for Civil Rights in San Francisco. A skilled law school professor with over 20 years of classroom experience, Grossman will provide the audience with clear, useful tools for making good compliance decisions regarding students. He will explain that accommodations are not merely suggestions but that genuine qualification remains an essential standard protected by the Americans with Disabilities Act. With his intersectional view of civil rights, Grossman will also share the "universal design" practices that he developed in his own classroom to the advantage of all students.
